To avoid fines and other legal action, you are urged to contact the DEP in Meadville at 814-332-6945 prior to demolition. Documentation of findings is required prior to issuance of permit.
All demolition debris and materials shall be properly disposed. Improper disposal may result in prosecution by the DEP.
Burning of debris and other materials is prohibited within Borough of Edinboro limits.
All borough supplied utilities such as sanitary sewer, storm sewer and water service shall be properly terminated and capped. YOU ARE REQUIRED TO CONTACT THE BOROUGH OFFICES WHEN TERMINATIONS ARE COMPLETED FOR BOROUGH INSPECTION. DO NOT BACK FILL UNTIL AUTHORIZED TO DO SO. Failure to comply will cause the Borough to require re-excavation of terminated utility for inspection.
Demolition sites shall be secured to prevent unauthorized entry.
Basements shall be backfilled with clean soil and fill and compacted to preventing settling. Top layer shall be topsoil suitable to promote and sustain vegetation.
Grass and vegetation shall be replanted unless an immediate construction project is to commence.
All mud and debris shall be removed from Borough streets immediately.
